## The QBN967 Singing Competition TERMS AND CONDITIONS OF ENTRY

1. To be eligible to enter in the QBN967 Singing Competition the performer must live in the Queanbeyan / Canberra regions.  
Proof of address is required (please send photocopy of photo ID with this application).
2. The performer must be between the ages of 13 and 16 years old.  
Proof of age is required where requested.
3. The QBN967 Singing Competition is for performers that are **not** already committed to any major or minor publishing and/or recording contract.
4. Voting for each contestant will be via the QBN967 website each week. Only one email vote will count per person, with the highest number of votes received by one contestant (in each age group) declared the winner at the close of the nominated day of the week. The winner of each age group will go onto the next round. Elimination is by the lowest number of votes received by a contestant between the previous weeks contestants in each category.
5. Any decision made by the organisers and judges is final and will not be reviewed.
6. Entrants agree that the details supplied on the entry forms, the images and music supplied, or images and recording of the event can be used to publicise and promote future events.
6. All singers must be at the venue not later than 6.30pm on the evening of the performance and report to the Event Manager. Any singer arriving after this time will be deemed a no show and forfeit their entry.
7. Singers to provide their own backing musical instrument (guitar, electric piano, bagpipes etc) to accompany their own performance, or have one person to accompany them for their performance. **BACKING music on CD's WILL NOT BE PERMITTED** and **NO** harmonies allowed during the performance.
8. Each singer will be permitted to sing one song **ONLY**.
